

**Cumberland Wrestling Association**  
**Minutes**  
**May 2, 2007**

Meeting was called to order by President Olson at 6:40 p.m.

**Approve Minutes of Previous Meeting**

Bob Cifaldi made a motion to approve the minutes of the April 11, 2007 meeting. Ken Sparish seconded.

**Treasurer's Report**

No treasurer's report was available. Bills were presented for payment by the following:

- Keocik Trophy Bill \$577.83 (approved in entirety)
- Ric Hensel (web site) \$39.00. Discussion was held pertaining to Mr. Hensel's bill. Motion was made by Jim Richie to pay Ric Hensel \$150.00 (which included the \$39.00 bill already submitted). Motion was seconded by Ken Sparish.
- John Olson/Skiddies Bill (youth banquet) \$500.00. Discussion was held pertaining to Mr. Olson's bill. Motion by Kay Capra to pay John Olson \$550.00 (which included \$50.00 for him and his daughter to work at the banquet). Motion was seconded by Jim Richie.
- Bernick's Pepsi Bill \$711.45 less \$252.45. Motion made by Kay Capra to pay Bernick's \$459.00. Seconded by Jim Richie.

**Old Business**

Bob Erickson updated the Committee on the Augsburg camp. He needs 10 kids to participate, and two coaches would be free. Bob has confirmed with Seth Strickland to coach, but has not found the second coach. The camp is June 17-21 for grades 8-12. Cost is \$310.00. In the past, the Association has contributed \$100.00 per wrestler. Discussion was held on some wrestlers' financial issues. The Committee will explore the possibility of paying extra for certain wrestlers if needed.

Bob Erickson also indicated that the Victory School of Wrestling is holding camps in River Falls on May 6, May 27 and June 5. Bob has passed the word along to wrestlers and some are planning to attend.

Chad Olson updated the Committee on the open wrestling room for the summer. Chad confirmed with Betsy Hart of Community Ed that the wrestling room will be open Sunday nights in the summer, with two supervising adults. The Committee decided that Sunday, June 10 through Labor Day would be appropriate. The time would be 6-7:30 p.m. Tony Capra will attempt to put together a list of adult supervisors, as well as get the information to Ric Hensel for the web site.

Chad Olson updated the Committee on the wall in the gym. Ron Hellstern has agreed to update the wall. Tony Capra will get Ron the last four years of history.

Jim Richie talked about an upcoming camp at the Rice Lake High School. The camp is June 14-15 (9-3 p.m.). Cost is \$20.00, which includes lunch for both days. Jim handed out flyers on this camp, and Tony Capra will get it on the web site.

Discussion was held on the Black Wrestling Camp. Some people have been approached on attendance of wrestlers from outside schools. It was determined that a \$50.00 fee would be charged for wrestlers from other schools that want to attend.

Sara Peterson brought up the Association dues, and a discussion was held on why some Middle School kids did not have to pay dues. It was determined that the issue of dues would be addressed in the new by-laws.
